

EULA – End User License Agreement "MOBIO Database"

Version 1.1 -- 03th December, 2009

By signing this document the user, intended as who will make use of the database or the database interface, agrees to the following terms. By database both the actual data and the interface to the database are meant.

1. Commercial use

The user may not use the database for any commercial purpose. Commercial purposes include, but are not limited to:

- proving the efficiency of commercial systems,
- testing commercial systems,
- using screenshots of subjects from the database in advertisements,
- selling data from the database,
- broadcasting data from the database.

2. Distribution

The user may not distribute or broadcast the database in any way. Small portions (i.e.: screenshots) may be distributed in publications as long as the publication complies with the terms stated in this EULA (article 4).

The user will forward all requests for copies of the database to the MOBIO database administrators at:

3. Access

The user may only use the database after this EULA has been signed and returned to the "Idiap Research Institute" - Martigny – Switzerland and the MOBIO "Mobile Biometry" EC FP7 research project [214324]. The user must return the signed and dated EULA by email, in PDF format:

Multiple users may sign one EULA in order to grant access to a group of researchers. Each researcher will however be given an individual user-name and password.

The user may not grant anyone access to the database by giving out their user-name and password.

4. Publications

Publications include not only research papers, but also presentations for conferences or educational purposes.

All documents and research papers that report on research that use the MOBIO database will acknowledge this as follows: "(Portions of) the research in this paper use the MOBIO database made available by the Idiap Research Institute, Switzerland", and a citation to:

5. Research

The user may only use the database for scientific research.

6. Changes

Both the MOBIO "Mobile Biometry" EC FP7 research project [214324] and the Idiap Research Institute – Martigny - Switzerland are allowed to change this EULA at any time; users will be informed about changes beforehand and given the choice to opt out of the new EULA. Opting out will render the previous EULA void.

7. Warranty

The database comes without any warranty, neither the MOBIO "Mobile Biometry" EC FP7 research project [214324] nor the Idiap Research Institute – Martigny – Switzerland can be held accountable for any damage (physical, financial or otherwise) caused by the use of the database. The MOBIO research project [214324] and the Idiap Research Institute will try to prevent any damage by keeping the database virus free.
